




Conference Layout

Loews Atlanta Hotel, Atlanta, Georgia


All conferences spaces are located on the 14th floor.






Exhibition Hall Layout

1. Agreement Activation

2. Binding Contract

Submission of this form constitutes a legally binding agreement between the Exhibitor and NAYGN.

3. Indemnification

Each party agrees to indemnify and hold harmless the other party and its employees, members, landlord, successors, and assigns, from any claims, liabilities, losses, damages, and expenses asserted against the other party and arising out of the indemnifying party's negligence, will full misconduct, and negligent performance of, or failure to perform, any of its duties or obligations under this Agreement. The provisions of this indemnification are solely for the benefit of the parties hereto and not intended to create or grant any rights, contractual or otherwise, to another person or entity.

4. No Endorsement

Participation in the event does not imply endorsement of any product, service, or organization by NAYGN.

5. Intellectual Property

Exhibitors are solely responsible for ensuring that all materials used or distributed by them comply with applicable trademark, copyright, and patent laws.

6. Subletting Prohibited

Booth space may not be shared, transferred, or sublet without prior written approval from NAYGN.


7. Compliance with Rules

The Exhibitor agrees to abide by all regulations and rules adopted by NAYGN in the best interests of the Conference and agrees that NAYGN shall have the final decision in adopting any rule or regulation deemed necessary prior to, during and after the Conference.

8. Liability for Damages

Exhibitors are liable any loss or damages whatsoever suffered by NAYGN as a result of any loss or damages whatsoever occurring to or suffered by any person or company, including without limiting the generality of the foregoing, Exhibitor, other Exhibitors, NAYGN, the owner of the building and their respective agents, servants and employees and members of the public attending the Conference, either on the said space or elsewhere if said loss or damages arose from or were in any way connected with Exhibitor's occupancy of said space.







9. Booth Assignment

NAYGN reserves the right to alter or change the space assigned to the Exhibitor at its discretion.

10. Conduct and Presentation

NAYGN reserves the right at any time to alter or remove exhibits or any part thereof, including printed materials, product, signs, lights, or sound, and to expel Exhibitors or their personnel if, in NAYGN's opinion, their conduct or presentation is deemed inappropriate, disruptive, or offensive to attendees or other exhibitors.

11. Booth Use

Exhibitor agrees to confine their presentation within their assigned booth space and adhere to height and display restrictions. Booths must be staffed during all exhibit hours.

12. Loss or Damage

NAYGN assumes no responsibility for any loss, theft, or damage to exhibitor property before, during, or after the event.

13. Insurance

Exhibitors are responsible for securing and maintaining appropriate insurance coverage for their participation in the Conference.

14. Move-Out Requirements

The Exhibitor agrees that no display may be dismantled during the entire run of the Conference and must remain intact until the closing hour of the last day of the Conference. The Exhibitor also agrees to remove their exhibit, equipment, and appurtenances from the Conference building by the final move-out time limit, or in the event of failure to do so, the Exhibitor agrees to pay for such additional costs as they may be incurred.

15. Networking Sponsorships

NAYGN does not guarantee attendance levels at networking events. No refunds will be issued based on turnout.

16. Force Majeure

NAYGN reserves the right at its sole discretion to change the date or dates upon which the Conference is to be held and shall not be liable in damages or otherwise by reason of any such change. In addition, NAYGN shall not be liable in damages or otherwise for failure to carry out the terms of this Agreement in whole or in part where, caused directly or indirectly by, or in consequence of, fire, storm, flood, war, rebellion, insurrection, riot, civil commotion, strike or by any cause whatever beyond the control of NAYGN whether similar or dissimilar from the causes enumerated herein. In the event that the exhibit space to be used by the Exhibitor should in any way be rendered unusable, the Exhibitor shall pay for such space only for the period during which it was or could have been used as determined within the sole discretion of NAYGN. A refund of all monies paid by the Exhibitor to NAYGN will be made by NAYGN in the event that the Conference is fully canceled.

17. Contract Termination

NAYGN reserves the right to cancel this contract and to withhold possession of exhibit space if the Exhibitor fails to perform any material condition of this contract or refuses to abide by the Conference rules and regulations, in which case the Exhibitor shall forfeit as liquidation damages all space rental payments made by them and any further occupancy of such space.

18. Labor and Union Compliance

The Exhibitor agrees to observe all union contracts and labor relations in force, agreements between NAYGN, official contractors serving companies and the building in which the Conference will take place and according to the labor laws of the jurisdiction in which the building is located.
